## Capitol Report: disappointing special session

When the regular session ended prematurely in a dispute over acceptance of federal healthcare dollars, a rare special session was called to adopt a budget, the one constitutionally-mandated responsibility of the Legislature. Sadly, the resulting budget was very disappointing.

### Affordable healthcare for all Floridians died in the House. Again.

Despite the Senate's efforts to provide health coverage to over 800,000 of Florida's working poor, the House again refused to accept federal dollars. As a result the Legislature cut Floridians' anticipated budget surplus dramatically, almost a million Floridians continue to live without basic health coverage, and \$51 billion of Florida's tax dollars will not come back to our state.

### Budget surplus slashed

The rejection of Florida's federal healthcare funds halved the \$1 billion budget surplus promised by Governor Scott in his re-election campaign. Instead the Governor signed HB 33A, providing Floridians with a tax cut of

just \$372 million. The tax cut package will reduce costs on cell phone bills, cable TV bills, gun club memberships, college textbooks and luxury boat repairs.

### Amendment 1 sabotaged

Backers of the Land & Water Legacy ballot initiative contend lawmakers "ignored" the desires of voters by using a boost in environmental funding to cover the costs of daily state operations while setting aside too little for land purchases. Frustration with low allocations over the previous few years drove voters to demand higher funding levels through Amendment 1, which authorizes lawmakers to spend up to \$300 million a year for preservation and land and water protections across Florida. Unfortunately, even with this significant influx of Amendment 1 dollars, environmental funding in the upcoming budget has been reduced from last years' level.

Our job is not done: 2016 Legislative Committee Weeks will begin in less than 90 days. In a democratic society, the work of voters never ends.

## LWVFL Study on Open Primaries

In May LWVFL Convention attendees voted to conduct a statewide study of the different types of open primaries to determine which one would be the best fit for Florida, which currently has closed primaries. An Open Primary is one in which any registered voter may participate, regardless of party affiliation (or lack thereof).

League's primary mission is to enable and encourage all eligible citizens to vote, with a goal of increasing voter turnout. This study will determine (1) if Florida's current closed primary system hinders voter participation; and (2) which type of open primary would be best for Florida. A partial list of the many types of open primaries follows.

**Open partisan primary:** Voters may select either party ballot, but are limited to that ballot. Political parties cannot prevent non-members from voting their party ballot.

**Nonpartisan primary:** One election, where all voters and candidates participate on a single ballot.

**Top-two primary:** In lieu of partisan primaries, all candidates appear on the same ballot, regardless of party affiliation. The top two vote getters move on to the general election.

**Instant run-off:** Voters rank candidates in order of preference. A candidate must receive more than 50% of the first-choice votes to win. If no candidate receives more than 50% of the first-choice votes, the candidate with the fewest number of first-choice rankings is eliminated, and these votes are redistributed. This process repeats until one of the candidates receives more than 50% of the votes.

**Hybrid:** Many state primary systems fall somewhere in between "open" and "closed." Procedures are unique from state to state, and how to categorize these primaries is a judgment call.

You needn't be a member to join in the open primary study, but you must be a member to participate in consensus. Join now for just \$15 and find out what it means to be a Leaguer!
