## Voter disenfranchisement hits home

In 1998, the Florida Constitution Revision Commission (FCRC) placed Amendment 11 (<https://tinyurl.com/j47mza3>) on the ballot. The amendment's purpose was to provide fairer elections by—among other things—allowing all voters, regardless of party affiliation, to vote in a primary election in which all of the candidates for the office have the same party affiliation and the winner will have no opposition in the general election. Sixty-four percent of Florida voters approved Amendment 11.

Unfortunately, the Florida Legislature could not agree on whether or not write-in candidates should be allowed to close a primary. So, then-Secretary of State Katherine Harris wrote a rule in 2000 that ensured an acceptable opponent could include a write-in candidate. This allowed someone with no funding, no name on the ballot and no campaign committee to close primary races and reserve the voting for members of one party only. Since then both major parties have used this loophole to disenfranchise other voters and preserve their party's control.

Based on the FCRC's legislative history, as well as conversations with a member of the 1998 Commission, it's clear they did not believe a blank space on a ballot qualified as an "opponent." Neither they nor the voters who passed the amendment expected the result that followed. Numerous lawsuits have challenged the "write-in loophole" over the intervening years, all unsuccessfully. Most recently, on 4 Feb 2016, the Florida Supreme

Court issued a unanimous opinion (<https://tinyurl.com/zlq5kst>) that agrees with the Florida State Court of Appeals that write-in candidates in general elections are "real" candidates.

Why the history lesson? In 2014 our County's Supervisor of Election publicly called out potential write-in candidates for attempting to close important primaries, and they backed down. As a result, all of Okaloosa's registered voters had a say in their local and state representation that year. In 2016 it's a different story. Write-in candidates closed three very important races at the last minute, including the District 1 Board of County Commissioners (BCC) seat, District 1 State Senator and District 4 State Representative. Write-in candidates do not pay filing fees or need signed petitions to enter the race, and their names don't even appear on the General Election ballot, but their candidacy effectively disenfranchises one third of Okaloosa County's registered voters.

Former Crestview City Council member and previous Clerk of Court candidate Charles Baugh is actively campaigning for the BCC seat, but write-in Christopher Schwantz readily admitted (<https://tinyurl.com/hfur5d8>) that he filed specifically to close the State Representative race. So unless County voters register with the GOP by 1 Aug, they will have no say in who will represent them in the Legislature in the near term. Welcome to democracy, "Florida-style."

## Yes on 4: Tax exemptions for renewable energy

Want to know the best-kept secret in Florida about one of the biggest barriers holding back meaningful solar development? It's not lack of sunshine, it's **taxes**—really burdensome taxes whose impact drives up the cost of solar power. The Sunshine State should not be taxing the sun.

Taxes are big reason that Florida, which has 9 million energy customers, boasts only 8,500 rooftop solar systems. By comparison, New Jersey has over 43,000 rooftop systems with half the population and less sun.

Florida voters will have an opportunity to change that on 30 Aug. A "YES" vote

on Amendment 4 on your primary ballot will lower taxes on solar panels for 20 years, thus making them more affordable. Access to affordable solar energy will lower overall energy costs for consumers. This is a win for Florida residents AND the environment.
