Okaloosa County SOTC

from the Judiciary, the School Board and the County Commission.

Panelists will include Sheriff Mike Adkinson, County Commission Chair Tony Anderson, and hopefully School Superintendent Russell Hughes (not yet confirmed).

With only days to go in the 2019 legislative session, lawmakers have already attacked Amendment 4; continued to siphon funds from public schools; attempted to arm schoolteachers; and ignored our environment in favor of business interests. FLORIDA MEDICAID EXPANSION CAMPAIGN

Florida has not expanded Medicaid under the Affordable Care Act. If it did so, over 700,000 Floridians—including working parents, retirees and veterans—would get much-needed access to preventive care, cancer treatments and prescription drugs, and the federal government would cover 90% of the cost. Additionally, Florida Policy Institute has estimated that Medicaid expansion would save our state over \$500 million each year while also covering more people.

Medicaid expansion offers many financial benefits for enrollees and the state.

Enrollees

- Have less medical debt and are better able to afford food and other essential goods and Services
- Have better credit and lower interest rates on borrowed money
- Are less likely to declare bankruptcy
- Have better work performance
- If unemployed are better able to look for work

- Are more sustainable
- Able to maintain quality care
- Less likely to close

2020 marks the 100th anniversary of League and the 19th Amendment. 2018-20 Impact on Issues

LWV is an activist, grassroots organization whose leaders believe that people should play a critical role in democracy. To that end League's 2018–20 Impact

reduced funding for health-related services

- Benefit from higher reimbursement rate for adults currently covered by regular Medicaid
- Experience increased employment
- Have increased economic activity

Since politics has prevented expansion so far, now is time to take the question directly to Florida voters and ask them to approve a ballot measure to expand Medicaid. To qualify for the November 2020 ballot, the initiative language must first be reviewed by the Attorney General and the Florida Supreme Court. For that we need at least 100,000 verified petitions each from 7 congressional districts in the state. LWVF kicked off the petition collection drive in April.
