LWVUS Immigration Study

In 2006 the League of Women Voters launched a study of immigration aimed at helping communities understand the implications of immigration at the local, state and federal level. The study is exploring the underlying values and principles regarding immigration, reasons for immigration, current federal immigration policy, and the impact of immigration in American society.

League members should make every effort to educate themselves during the study, because ultimately they must come to some broad agreement on their values regarding immigration. *The League calls this consensus*. LWVUS will use this consensus to form a position that will be used for years to come to affect national policy. Helping to reach consensus and form a position for the

League's national program may be a League member's most important role.

LWVOC will be studying the issue from Sep 07 - Jan 08. There will be a study session in November in addition to a general meeting on the local impact of illegal immigration. The consensus meeting will be held on Jan 5, 2008.

To prepare for study sessions, go to www.lwv.org/lmmigrationStudy/ and review the study materials. These include a historical perspective on immigration, two study briefs, eight background papers on various aspects of the issue and numerous other resources.

Action Alert: Protect America Act

The League of Women Voters believes in the individual liberties guaranteed by our Constitution, and that individual rights now protected by the Constitution should not be weakened or abridged.

In August Congress passed the Protect America Act (S. 1927). This bill permits massive, untargeted collection of international communications without a court order or meaningful oversight by either Congress or the courts. It also has virtually no protections for the U.S. end of the phone call or email, leaving decisions about collection, mining and use of Americans' private communications solely up to the executive branch.

Contact your Senators and Representatives now, and let them know you oppose this expansion of governmental powers and its infringement of civil liberties.

State League 2008 Legislative Priorities

Government in Florida: Promote an open government that is responsive to the people of the state.

- Equitable Taxation: Support a state fiscal structure that is responsive to public needs and distributes tax responsibility equitably.
- Redistricting: Support single-member election districts that provide access for minorities, are equal in population, and are not determined by the legislature.
- Citizen Initiatives including the Statutory Initiative: Support the right of citizens to have both constitutional and statutory initiatives.

Natural Resources and Sustainability: Promote an environment beneficial to life through the protection and wise management of natural resources in the public interest, and support governmental action that results in sustainability.

- Protection and restoration of the water supply: Support public policies that promote conservation of freshwater and its availability for environmental, public supply agricultural, industrial and mining uses on a priority basis.
- Coastal Management: Support intergovernmental stewardship of and fiscal responsibility for the Florida coast, under the management of the state, while recognizing the dominance of nature and the role of the sand transport system.
- Energy: Support environmentally sound policies that reduce energy growth rates, emphasize energy conservation and encourage the use of renewable resources.

The 19th Amendment Celebrates its 87th Anniversary

In August 1920, the 19th Amendment was one state shy of ratification when it came up for vote in Tennessee. With the vote pending on August 18, the amendment seemed headed for defeat. However, Rep. Banks Turner came over to the Suffragist's side in the first roll call, tying the vote at 48 to 48. The vote was still deadlocked after the second roll call.

The legislators had squared off for the third roll call when Harry Burn—wearing the red rose of the anti-suffragists—voted in favor of the bill. With his "yea," Burn delivered universal suffrage to all American women. Outraged opponents

chased Burn around the room, and he was forced to climb out a window and hide in the Capitol attic to save himself.

Burns later explained that the red rose on his lapel covered the telegram in his pocket, in which his mother urged him to do the right thing and vote in favor of the amendment. Over 144 years after the Declaration of Independence, American women finally had the right to vote-thanks to Febb Ensminger Burn and her son, Harry.

And it all came down to a single vote!

Taxation & Budget Reform Commission Hearing Set

The Florida Taxation & Budget Reform Commission will hold a public hearing on Thursday, Oct 18, 2007, from 4:00-7:00 p.m. in the Mattie Kelly Fine & Performing Arts Center at Okaloosa Walton College, 100 College Boulevard, Niceville.

Members of the public will be able to share their recommendations on taxation and budget issues with the Commission, which meets once every 20 years to examine the state's budget process, revenue needs, tax structure, productivity and efficiency, and the ways state and local governments meet their revenue needs. The Commission may recommend any changes it deems appropriate to the constitution or taxation and budget laws. Because it meets so infrequently, the Commission must take a long-range view in all its recommendations and analyses.
